

**BP Forecourt**  
**Happy Hour Here 5 Times a day – Monday to Friday**  
**Terms & Conditions**

The terms and conditions set out below ("Terms and Conditions") apply to the BP Forecourt Happy Hour Here 5 Times a day (the "Promotion") being run and administered by BP Southern Africa (Pty) Ltd (the "Promoter" or "us" or "we" or "BPSA"). These Terms and Conditions will prevail in the event of any conflict or inconsistency with any other communications we send you, including advertising or promotional materials. Prize redemption instructions are deemed to form part of the Terms and Conditions and by entering the Promotion all participants will be deemed to have accepted, and shall be bound by, the Terms and Conditions. This version of the Terms and Conditions applies to participants in the Republic of South Africa.

1. The Promoter is BP Southern Africa (Pty) Ltd [Registration Number: Reg 1924/002602/07 8-10 Junction Avenue Parktown].
2. The Promotion is only valid in South Africa and is open to every South African citizen of the age of 18 years and older.
3. The Promotion is not open to any agencies, sales agents/ merchandisers, packaging suppliers and their immediate family members (spouses, life partners, parents, grandparents, siblings, children and grandchildren) or their business partners, or any person who is a director, member, partner, or agent of, or consultant to the Promoter, or any other person who directly or indirectly controls or is controlled by the Promoter; or (ii) a supplier of goods or services in connection with the Promotion.
4. The Promotion is not open to employees of BP Southern Africa (Pty) Ltd and their immediate families.
5. Participation in this Promotion constitutes your acceptance of these Terms and Conditions. All information relating to this Promotion and published on any promotional material will form part of these Terms and Conditions of entry. The Promoter reserves the right to amend these Terms and Conditions in its sole discretion at any time, and the amendments will be deemed to have taken effect on the date of publication of the revised Terms and Conditions on the Promoter's website.
6. By participating in the Promotion you are consenting to your name and image being published (at no fee) on any traditional or digital communication channels should you be a winner. You have the right to withdraw your consent to have your image used in any marketing material or to participate in any marketing activity on written notice to the Promoter.

7. Any participant who is found not to be compliant with the rules of the Promotion shall be automatically disqualified. In the event of a dispute regarding the Promotion, the decision of the Promoter shall be final and binding.
8. The Promotion will run from 1 August 2018 at 00h00 and end on 31 October 2018 at 23h59. No winners will be selected before 1 August 2018 00h00 and after 31 October 2018 23h59 at selected BP Service Stations only.
9. The Promoter reserves the right to terminate the Promotion immediately and without notice, or on very limited notice, due to unforeseen circumstances arising which result in the Promotion no longer being financially viable to maintain and / or if circumstances beyond its reasonable control prevent the Promoter, its associated companies (directors, officers and employees) agents and suppliers, from continuing with the Promotion. This includes but is not limited to any directive from the Department of Energy to cease the Promotion. In the event of such termination, as far as the law allows, the participants acknowledge that they will have no recourse against the Promoter, its associated companies (directors, officers and employees) agents and suppliers, in respect thereof.
10. As far as the law allows the Promoter, its associated companies (directors, officers and employees) agents and suppliers, shall not be responsible for a participant's failure to access the Promotion for any reason whatsoever, including but not limited to a lack of availability of vouchers or fuel cards at any participating service stations for any period of time. Consumers wishing to participate in the BP Forecourt Happy Hour must:
  - 10.1 Spend R100 or more on fuel at any selected BP Forecourt
  - 10.2 Sign a consent form regarding the publication of their name and image (subject to clause 6 above)
11. You stand a chance to win either:
  - 11.1 a Fuel card worth R50, which must be used at a BP service station or
  - 11.2 a PnP Voucher worth R50, which must be used at a PnP Retail Outlet or PnP Express and cannot be redeemed for fuel
12. It is the winner's responsibility to check the balance available on the relevant gift card from time to time by contacting the relevant telephone number displayed on the card or by obtaining the relevant contact number from the promotional helpline numbers set out in clauses 25 and 26 below.
13. Prizes are awarded by the Promoter to the winner and are not transferrable. All prizes, or any portion thereof, **may not be exchanged for cash** and shall be used only for the purposes set out in clause 11 above.

14. Participants may not be winners more than twice in any 7 (seven) day period. A participant who is selected as a winner for the third time in any seven day period will be required to forfeit the prize.

Five winners will be selected daily (Monday to Friday) at random at the participating BP service station during three or more of the following Happy Hour time slots and will be handed the prize (which prize is made available by the Promoter and will be awarded for and on behalf of the Promoter to the winner by the Promoter's authorised representative at the participating BP service station) after making his /her purchase of R100 or more on fuel:
  - 14.1 06h00 to 08h00
  - 14.2 08h00 to 10h00
  - 14.3 12h00 to 14h00
  - 14.4 15h00 to 17h00
  - 14.5 17h00 to 19h00.
16. As far as the law allows, the participant shall have no claim whatsoever against the Promoter, its associated companies (their directors, officers and employees) agents and suppliers, should the Promoter's representatives at any of the participating BP service stations fail to conduct the relevant draw at the times specified for whatsoever reason or should the Promoter or its agents or representatives not be able to comply with the provisions of these Terms and Conditions for reasons beyond the reasonable control of the Promoter or its agents and/or representatives.
17. By accepting the prize, a winner acknowledges that she or he accepts the prize at his or her own risk.
18. Any participant who is found not to be compliant with the rules of the Promotion shall be automatically disqualified. In the event of any dispute regarding the Promotion, the decision of the Promoter shall be final and binding.
19. The Promoter, in its sole discretion, may decline to award a prize (i.e. refuse to issue a prize to the participant) if there is a reasonable suspicion of any irregularities or fraudulent activities. The decision of the Promoter in this regard shall be final and binding.
20. By entering this Promotion Participants are given the opportunity to Opt In to allow BPSA and the respective BPSA Brands to collect, store and use (not share) their personal information for communication, statistical purposes and for marketing communications.

22. As far as the law allows, all warranties and representations in relation to the Promotion not set out in these Terms and Conditions (whether express, implied or tacit) are hereby excluded.
23. These Terms and Conditions shall be governed by the laws of South Africa.
24. If any provision of these Terms and Conditions is found to be invalid or unenforceable by any court of competent jurisdiction, then that provision shall be severed from these Terms and Conditions and shall not affect the validity or enforceability of any remaining provisions.
