<b>Offer Period</b>	The offer (the <b>Offer</b> ) will remain open from 12:01am (AEDT) on 1st February 2025 to 11:59pm (AEST) on 31 <sup>st</sup> July 2025 ( <b>Offer Period</b> ). bp reserves the right to change or end this Offer on reasonable notice at any time.

	<p>Qantas Business Rewards using the same ABN as is registered against the business's BP Plus account;</p> <p>(e) transact at a bp retail site, purchasing any unleaded or diesel fuel grades (Autogas and AdBlue are excluded) (<b>Eligible Fuel</b>) using BP Plus as the method of payment; and</p> <p>(f) not have any overdue amount payable on their BP Plus account during the relevant transaction period.</p> <p>The Bonus Qantas Points and Discount (<b>Benefits</b>) will (subject to the above requirements) be applied from the date upon which a BP Plus application is approved, the account is opened, and membership of Qantas Business Rewards has been confirmed. <p><b>BP Plus Application</b></p>	<p>During the Offer Period, an authorised representative of a Participating Business aged 18 years or over must apply on behalf of the Participating Business to become a BP Plus business customer by fully completing and submitting a BP Plus online application form (available at <a href="http://www.bpplus.com.au">www.bpplus.com.au</a>) (<b>BP Plus Application</b>).</p> <p>BP Plus Applications will be subject to approval by bp in accordance with the BP Plus Terms and Conditions. BP Plus Applications must satisfy the full information disclosure requirements as stated on the BP Plus Application form, in order to be eligible. Processing of BP Plus Applications and credit approval may take up to four (4) weeks from the date of submission in some cases, subject to full information disclosure. If a business is not approved to become a BP Plus business customer by bp, the business will be ineligible to participate in this Offer.</p> <p>Transactions that are delayed due to system outages that bp could not reasonably avoid at bp sites, that are reversed, or that are or are reasonably suspected by bp as being fraudulent, will not have the Benefits applied to them.</p>
<p><b>Bonus Qantas Points</b></p>	<p>Participating Businesses that qualify for the Offer will be entitled to receive:</p> <p>(a) <b>three times</b> the base earn rate on Qantas Points for spend on all Eligible Fuel for a period of seven (7) "full months" from the BP Plus account open date until the last day of the seventh (7<sup>th</sup>) calendar month after the account open date (e.g. if the account open date is 15 February 2025, the end of seven (7) "full months" will be 30 September 2025) (<b>7 Full Months Period</b>); and</p> <p>(b) <b>100,000</b> bonus Qantas Points if 15,000 litres of Eligible Fuel or more is purchased in connection with the BP Plus account during the 7 Full Months Period. <b>Discount</b>	<p>Once a Participating Business has qualified for the Offer, the Participating Business will receive 6 cents per litre (<b>cpl</b>) off the pump price of all Eligible Fuel for the 7 Full Months Period. Discounts will only be available where Eligible Fuel transactions are made using the Participating Business' BP Plus account.</p> <p>Please note that:</p> <ol style="list-style-type: none"> <li>a. All Autogas and AdBlue purchases are excluded and will be priced in accordance with standard existing bp pricing offers, and in line with the then-current BP Plus Terms and Conditions;</li> <li>b. After the 7 Full Months Period has ended, a Participating Business' BP Plus account will convert to the BP Plus Qantas Business Rewards Offer, which is subject to the BP Plus Qantas Business Rewards Offer Terms and Conditions, available <a href="#">here</a>, as amended from time to time;</li> <li>c. 2. These Terms and Conditions incorporate and must be read together with the details outlined in the table above. Information on how to participate and receive benefits forms part of these Terms and Conditions. By participating, Participating Businesses accept these Terms and Conditions.
3. A Participating Business must comply with the BP Plus Terms and Conditions and the BP Plus Qantas Business Rewards Terms and Conditions and remain a BP Plus business customer with a valid ABN at all relevant times to receive the benefits of this Offer. To the extent of any inconsistency between these Terms and Conditions and the BP Plus Terms and Conditions, these Terms and Conditions prevail.
4. A Participating Business must comply with the Qantas Business Rewards terms and conditions at all relevant times.
5.
