- 2 These Terms and Conditions incorporate and must be read together with the details outlined in the

table above. Information on how to participate and receive discounts forms part of these Terms and Conditions. By participating, Participating Businesses accept these Terms and Conditions.

- 3 A Participating Business must comply with the BP Plus Terms and Conditions at all relevant times and must remain a BP Plus business customer at all relevant times to receive the benefits of this offer. To the extent of any inconsistency between these Terms and Conditions and the BP Plus Terms and Conditions, these Terms and Conditions prevail..
- 4 If the Promoter reasonably considers that a participant has breached these Terms and Conditions or the BP Plus Terms and Conditions, their participation in this offer and BP Plus may be deemed invalid.
