Who can participate?	<p>Participation in the Offer is open to any Australian business (Participating Business) who:</p> <ul style="list-style-type: none"> (a) does not hold a current BP Plus account and has not held a BP Plus account within the past 24 months; (b) is not a government-entity or similar public-sector business; (c) is not a BP-supplied distributor of automotive fuels; (d) is not subject to a strategic pricing arrangement with BP; and (e) is otherwise eligible to participate, as determined by BP in its reasonable discretion. <p>Participation in this Offer is subject to:</p> <ul style="list-style-type: none"> (a) the BP Plus Terms and Conditions, available here, as amended from time to time; (b) the BP Rewards Terms and Conditions, available here, as amended from time to time; and (c) the Qantas Business Rewards terms and conditions, available here. <p>Participation in this Offer is deemed acceptance of these Terms and Conditions.</p> <p>For the avoidance of doubt, and unless explicitly stated otherwise in these Terms and Conditions, participating in this Offer does not restrict a Participating Business from participating in any other BP Plus offer or promotion.</p>
Who can't participate?	<p>Participation in the Offer is not open to directors, officers, management and employees (and their immediate families) of:</p> <ul style="list-style-type: none"> (a) Qantas; (b) BP; or (c) the suppliers, agencies or companies associated with this Offer.
BP Plus Application	<p>During the Offer Period, an authorised representative of a Participating Business aged 18 years or over must apply on behalf of the Participating Business to become a BP Plus business customer by fully completing and submitting a BP Plus online application form or a paper application form (BP Plus Application).</p> <p>A Participating Business must either already be a Qantas Business Rewards member, or within 30 calendar days of being approved for a BP Plus account, become a Qantas Business Rewards Member, in order to be eligible to receive the Benefits.</p> <p>BP Plus Applications must be received and approved during the Offer Period, as determined by BP. BP Plus Applications will be subject to approval by BP in accordance with the BP Plus Terms and Conditions. BP Plus Applications must satisfy the full information disclosure requirements as stated on the BP Plus Application form, in order to be eligible. <p>Benefits</p>	<p>1. Subject to the eligibility requirements set out above in the ‘Who can participate?’ section, Participating Businesses that qualify for the Offer will be entitled to receive either:</p> <ul style="list-style-type: none"> (a) three times the base earn rate on Qantas Points for any calendar month during the Multiplier Period in which they spend \$500 or more on eligible fuel or shop products as listed in the BP Rewards Terms and Conditions (Eligible Products); or (b) four times the base earn rate on Qantas Points for any calendar month during the Multiplier Period in which they spend \$1,500 or more on eligible fuel or shop products; or (c) five times the base earn rate on Qantas Points for any calendar month during the Multiplier Period in which they spend \$3,000 or more on eligible fuel or shop products, <p>2. AND the qualifying business:</p> <ul style="list-style-type: none"> (a) successfully applies for, and is approved to open, a BP Plus account during the Offer Period; (b) is a member of Qantas Business Rewards within 30 days after being approved for a BP Plus account; (c) is and remains at all relevant times a member of Qantas Business Rewards using the same ABN as is registered against their BP Plus account; (d) transacts at a participating BP retail site, and purchases Eligible Products using BP Plus as the method of payment; and (e) does not have any overdue amounts payable on their BP Plus account during the relevant transaction period. <p>Benefits will only commence from the date upon which a BP Plus application is approved, the account is opened, and membership of Qantas Business Rewards has been confirmed. The Multiplier Period will run from that time until the end of the 6th full calendar month to elapse after that time. Once approved by BP, physical BP Plus cards may take up to two weeks to be delivered to a new customer. Virtual cards are available via the BP Plus mobile application, which may allow for immediate transactions from the time of account approval.</p> <p>Benefits will be applied based on applicable BP Plus account payments made while concurrently holding a BP Plus account and Qantas Business Rewards membership. The Benefits (if any) will be provided within six weeks of the qualifying business paying in full (and on time) its BP Plus account for the relevant calendar month. Benefits only apply to the earn rate on Qantas Business Rewards points earned by buying Eligible Products.</p>

 2. These Terms and Conditions incorporate and must be read together with the details outlined in the table above. Information on how to participate and receive benefits forms part of these Terms and Conditions. By participating, Participating Businesses accept these Terms and Conditions.
 3. A Participating Business must comply with the BP Plus Terms and Conditions and remain a BP Plus business customer with a valid ABN at all relevant times to receive the benefits of this Offer. To the extent of any inconsistency between these Terms and Conditions, the BP Plus Terms and Conditions and any other information provided by BP, BP will determine the prevailing term/s.
 4. A Participating Business must comply with the Qantas Business Rewards terms and conditions at all relevant times.
 5. If a participant is deemed by BP to breach these Terms and Conditions, the BP Plus Terms and Conditions, the BP Rewards Terms and Conditions, or the Qantas Business Rewards terms and conditions, their participation in this Offer and BP Plus may be deemed invalid.
