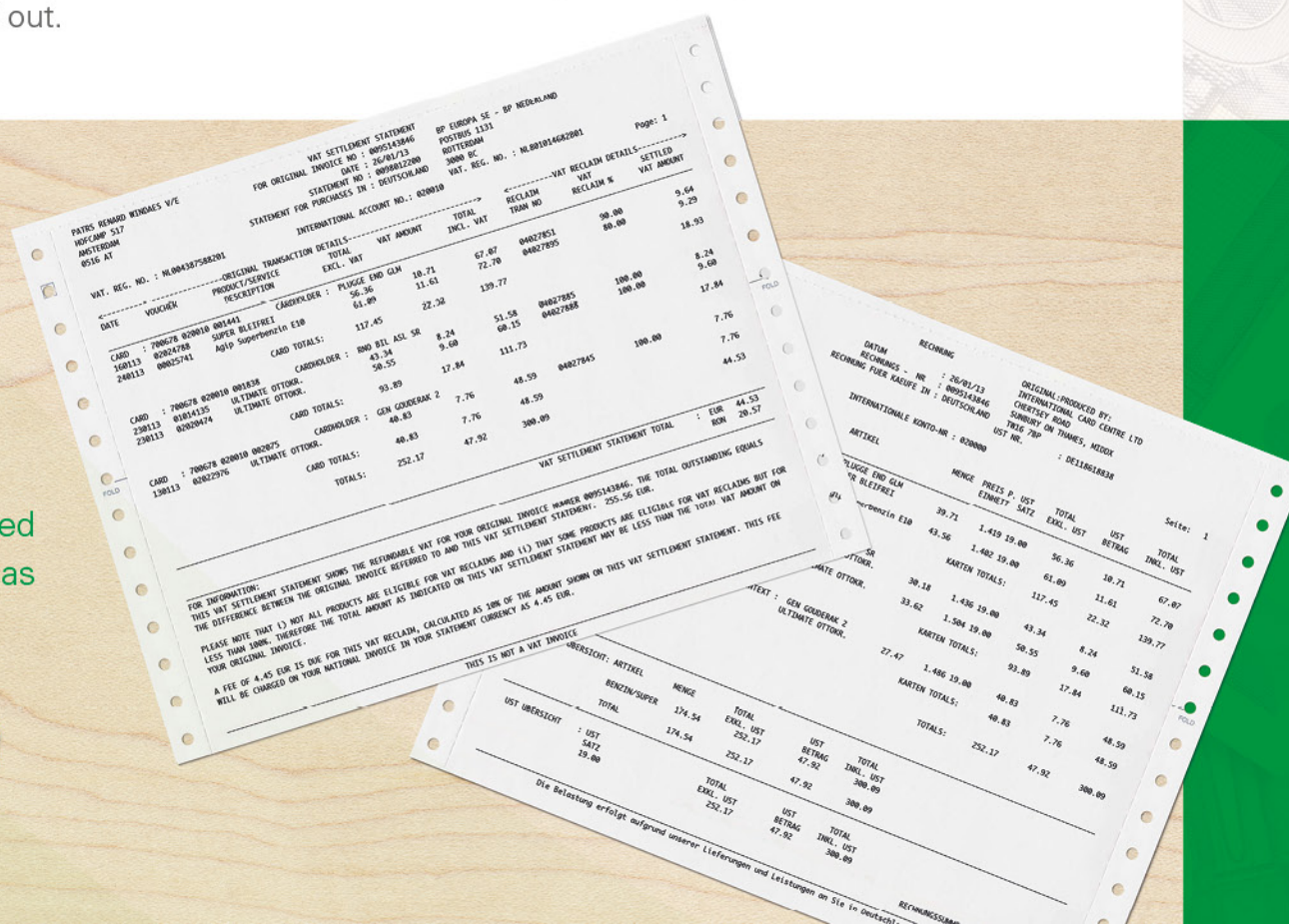
Why choose BP PLUS? The three tiers of our service
