Terms and conditions for Spin to Win Competition (No Purchase Necessary)

1. Introduction These terms and conditions (the "Terms") govern your participation in the "Spin to Win" competition (the "Competition"). By entering the Competition, you agree to be bound by these Terms. Please read them carefully before entering.

2. Eligibility The Competition is open to residents of England, Scotland, Wales and Northern Ireland aged 18 years or over, except employees of bp Plc and their immediate families, or anyone professionally associated with the creation or operation of the Competition.

Senior government officials and sanctioned individuals are not eligible to enter or win any Prizes. No purchase is necessary to enter the Competition or win a Prize.

3. 6. Winner Selection Prizes 1 - 5: Provisional Winners will be selected immediately after they spin the wheel and land on one of these Prizes. Their data will then be captured and a counter check done within 5 working days to validate the requirements of entry Prizes 6-10: Winners will be selected immediately after they spin the wheel and land on one of these Prizes.

7. Winner Notification Prizes 1-5: The provisional Winners will be contacted via the email address provided upon entry within 5 working days of Winner selection. Reasonable efforts will be made to contact

the provisional winners. If a provisional winner does not respond to the initial contact within 14 days once contacted, the Promoter reserves the right to disqualify that entrant

Prizes 6-10: Winners will be instantly notified of their win upon winning one of these Prizes.

8. Prize Acceptance:

Prizes 1-5: Once eligibility of a Prize is confirmed and the Prize is accepted, tickets will be issued within 14 days of acceptance of the Prizes.

Prizes 6-10: Once eligibility of a Prize is confirmed and the Prize is accepted, Winners will be awarded their Prize immediately after selection on-site.

8. Publicity By entering the Competition, you grant the Promoter the right to use your name, image, and entry for promotional purposes without further compensation, unless prohibited by law. This data will be inputted into a secure spreadsheet and provided to a third-party fulfilment agency to deliver the Prize (tickets). The fulfilment agency will contact the winner directly to send the tickets.

10. No Purchase Necessary No purchase is necessary to enter or win the Competition. A purchase will not increase your chances of winning.

11. Liability The Promoter and its affiliates accept no liability for any loss, expense, or damage (whether or not arising from any person's negligence) in connection with the Promotion and/or Prizes, other than such liability that cannot be excluded by law.

14. Suspension/Modification of Competition The Promoter reserves the right to cancel, amend, terminate, or temporarily suspend this Competition at any time where it considers that it is necessary to do so.

15. Invalid Entries If there are reasonable grounds to believe that there has been a breach of these Terms by an entrant, the Promoter may, at its sole discretion, invalidate the relevant entry and disqualify the entrant from the Competition, irrespective of the stage in the Competition reached.

16. Final Decision The Promoter's decision in all matters relating to the Competition is final and binding, and no correspondence will be entered into.
