

## TANGGUH COORDINATION WITH POLICE DURING YEAR 2011

The Integrated Community Based Security (ICBS) program was designed with the goal of providing those who live and work around Tangguh LNG with a safe and secure environment. It was formulated in collaboration with the Indonesian authorities to address the security and human rights concerns of all stakeholders based on partnerships between Tangguh, the communities, and the government's security providers. As such, on April 16, 2004, a Security "Field" Guidelines Agreement was executed between the Papua Police and BP, as operator of Tangguh LNG<sup>1</sup>. The Field Guidelines set forth the measures to implement the broader Memorandum of Understanding dated August 22, 2003 between BPMIGAS (Indonesia's upstream oil & gas regulatory body) and the Indonesian Police concerning security of oil and gas projects throughout the Republic of Indonesia. This field Security Guidelines Agreement is applicable for 5 (five) years and has been renewed on August 6, 2009.

The Field Guidelines are aimed at ensuring that the working conditions at Tangguh LNG remain secure, in order, and without violation of the law. They cover the provision of security at the project and at associated project facilities. The Field Guidelines make clear that BP is responsible for primary security provided by unarmed private security guards. The Guidelines also specify the procedures to be followed whereby BP can request assistance from the police, and the procedures to be followed by the police in deploying such assistance.

The Field Guidelines describe specific commitments of both BP and Police with respect to bearing the costs of security for Tangguh. In this regard:

- Each respective organization will bear its own cost for the conduct of its activities or the discharge of its basic obligations under the Guidelines.
- All costs, payments, and provisions of materials or supplies will be open and transparent and either side has the discretion to publicly disclose this information.
- If BP requests security assistance from the police:
  - With BP approval and request for payment, BPMIGAS (the Indonesia upstream oil & gas regulatory body) will make payment for transportation, lodging, meals, and daily allowances.
  - The amount and procedure for payment will be based on standards and procedures issued by BPMIGAS.
  - BP will not be obligated to pay for any support unless previously approved and accepted by BPMIGAS as 'cost recoverable' based on the applicable production sharing contracts and approved by BP Management and its investment partners in the Tangguh project. BP will not be allowed and will not provide any weapon, weaponry, ammunition or any funding to support the procurement of these items.

## Payments in 2011 in Direct Support of Tangguh Security

In 2011, several activities in regard to ICBS and Security operations were conducted. Most of the activities were milestones to the ICBS program, such as (1) Voluntary Principles on Security and Human Rights (VPSHR) In House Training (IHT) for both Public Security Forces and BP Security; (2) Police assistance to handle blockades by the community; (3) Police involvement in the Directorate General of Oil and Gas (MIGAS)'s explosives storage inspection; (4) Coordination meeting with Papua Police and Papua Military to discuss security situation in Timika regarding with BP's new project; (5) Police assistance during the Papua Barat Governor election (PILKADA).

## Background of Activities

**Voluntary Principles of Security and Human Rights (VPSHR) in-house training (IHT)**: To follow up on the VPSHR Training of Trainers program, trained participants of the program conducted in-house training to their fellow security personnel within and surrounding Tangguh LNG. The trainings were held in several places, such as Army Platoon in Bintuni, Polres Bintuni, Polres Fakfak, Polsek Babo, Brimob Manokwari.

**Police assistance to handle blockades by the community:** BP Security requested police assistance to prevent disruption of business operations and release BP's assets during blockades by the community at Babo and Biak airports. The blockade in Babo involved the detention of chartered boats at Babo Jetty and a blockade of the Babo airstrip due to labor disputes. In Biak, the community demonstrated at the airport.

**Police involvement in the MIGAS's explosives storage inspection:** Bintuni Police was part of the team from MIGAS in the annual inspection of explosives storage for drilling activities, which is a requirement for storage permit renewal.

**Coordination meeting with Papua Police and Papua Military to discuss security situation at Timika regarding with BP's new project:** Coordination meeting involving Polres Timika and TNI's Strategic Intelligence Body (BAIS) at Komando Distrik Militer to discuss about BP's seismic plans in Timika.

**Police assistance during the Papua Barat Governor election (PILKADA):** Police support was required during the PILKADA at Tangguh LNG on 9 Nov, 2011, to ensure the security and safety of all employees scheduled to vote (approx. 900 employees). Also, police support was necessary to safeguard the 2 election boxes and 6 voting cubicles.



A summary breakdown of payments is listed in the table below:
