

TANGGUH COORDINATION WITH POLICE DURING YEAR 2015

The Integrated Community Based Security (ICBS) program was designed with the goal of providing those who live and work around Tangguh LNG with a safe and secure environment. It was formulated in collaboration with the Indonesian authorities to address security and human rights as well as transparency concerns of all stakeholders based on the partnerships between Tangguh, the communities, and the Government's security providers. As such, on April 16, 2004, a Security "Field" Guidelines Agreement was executed between the Papua Police (Provincial Police) and BP, as operator of Tangguh LNG¹. The Field Guidelines set forth the measures to implement the broader Memorandum of Understanding dated August 22, 2003 between BPMIGAS (Indonesia's upstream oil & gas regulatory body), now known as SKK Migas, and the Indonesian Police concerning security of oil and gas projects throughout the Republic of Indonesia. This Field Security Guidelines Agreement was renewed on August 6, 2009.

The Field Guidelines are aimed at ensuring that the working conditions at Tangguh LNG remain secure, in order, and without violation of the law. They cover the provision of security at the project and at associated project facilities. The Field Guidelines make clear that BP is responsible for primary security provided by unarmed private security guards. The Guidelines also specify the procedures to be followed whereby BP can request assistance from the police, and the procedures to be followed by the police in deploying such assistance.

The Field Guidelines describe specific commitments of both BP and the Police with respect to bearing the costs of security for Tangguh. In this regard:

- Each respective organization will bear its own cost for the conduct of its activities or the discharge of its basic obligations under the Guidelines.
- All costs, payments, and provisions of materials or supplies will be open and transparent and either side has the discretion to publicly disclose the information.
- If BP requests security assistance from the Police:
 - With Management approval and request for payment, BP will make payment for transportation, lodging, meals, and daily allowances.
 - The amount and procedure for payment will be based on standards and procedures issued by SKK Migas.
 - BP will not be obligated to pay for any support unless previously approved and accepted by SKK Migas as 'cost recoverable' based on the applicable production sharing contracts and approved by BP Management and its investment partners in the Tangguh project. BP will not be allowed and will not provide any weapon, weaponry, ammunition or any funding to support the procurement of these items.

Payments in 2015 in Direct Support of Tangguh Security

In 2015, several activities with regard to ICBS and Security operations were conducted as below:

1. **Joint Exercise Evaluation Meeting between Polda Papua and BP Indonesia:** This activity is held to evaluate and improve the partnership between Polda Papua dan BP Indonesia.
2. **Joint Sea and Land Security Patrol:** This activity is carried out jointly by Bintuni Marine Police and Tangguh Security, to perform and exercise quality security patrol.
3. **Providing Polo Shirts and Sweaters for Police officers who supported the Joint Patrol 2015 at Tangguh LNG.** To support the activity of the Joint Mobile Patrol between BP Security and Bintuni Marine Police in preventing and securing the exclusion zone from unauthorized trespasser.
4. **Coordination Meeting between BP Security with Polsek Babo to follow up on a workplace incident at Stinkul Camp:** This meeting is carried out to address, follow up and mitigate the workplace incident that occurred at Stinkul Camp.
5. **Inviting five Police officers, a doctor and a paramedic to certify the death of a contractor worker at Tangguh LNG:** BP security invited a number of Police officers, a doctor and paramedic to assess a contractor worker who passed away on 5 June 2015 at Tangguh LNG clinic and to issue a death certificate.
6. **Polsek Kokas' assistance to release BP's charter boat that was detained by local community at Otoweri:** BP security requested Polsek Kokas' assistance to help release BP's charter boat that was detained by local community at Otoweri.
7. **Supporting fast breaking event as part of Bhayangkara Day celebration:** To support one of the most important events of Police, the Bhayangkara Day (a national Police day), that was celebrated by holding a fast breaking activity.
8. **Voluntary Principles on Security and Human Rights (VPSHR) In-House Training (IHT) 2015 activities for Police officers and TNI-AD in Papua Barat:** This activity is conducted as a follow-up activity to previous VPSHR IHT.
9. **Preparatory Joint Exercise Meeting between Polda Papua and BP Indonesia:** This meeting is conducted to prepare the Joint Exercise between Polda Papua and BP Indonesia.

10. Socialization Meeting in Makassar: This activity is carried out to enhance the awareness and understanding of Police officers from Polres Bintuni regarding the security of Tangguh LNG project as a National Vital Object .
