Offer Period	<p>The '12 cents per litre discount offer', as set out in these Terms' (Offer), will remain open from 12:00:01 AM NZDT 23 May 2022 to 11:59:59 PM NZDT 31 July 2022 (Offer Period).</p> <p>The Promoter reserves the right to change or end this Offer without notice at any time and for any reason in its absolute discretion.</p>
Who can participate?	<p>Participation in the Offer is open to any registered New Zealand business (Participating Business) who:</p> <ul style="list-style-type: none"> (a) does not hold a current BP Fuelcard account; (b) is not a government-entity or similar public-sector business; (c) is not a bp-supplied distributor of automotive fuels; (d) is not subject to a strategic pricing arrangement with bp; or (e) is otherwise eligible to participate, as determined by bp in its sole discretion. <p>Participation in BP Fuelcard is subject to the BP Fuelcard Terms and Conditions, available here, as amended from time to time.</p> <p>Participation in this Offer is deemed acceptance of these terms and conditions.</p>
Who can't participate?	<p>Participation in the Offer is not open to:</p> <ul style="list-style-type: none"> (a) existing BP Fuelcard business customers who have not been invited by the Promoter to participate; (b) prospective or existing BP Fuelcard account holders who have been/are invited by the Promoter to participate in an alternate offer; and (c) directors, officers, management and employees (and their immediate families) of: <ul style="list-style-type: none"> (i) the Promoter; and (ii) the suppliers, agencies or companies associated with the Offer.
BP Fuelcard Application	<p>During the Offer Period, an authorised representative of a Participating Business aged 18 years or over must apply on behalf of the Participating Business to become a BP Fuelcard business customer by fully completing and submitting a BP Fuelcard online application form, or a hard copy application form provided by a BP representative (BP Fuelcard Application). Alternatively, if the Participating Business is an existing BP Fuelcard business customer who has been invited by the Promoter to participate the Offer, the Participating Business must follow any instructions provided by the Promoter to participate in the Offer.</p> <p>BP Fuelcard Applications must be received during the Offer Period, as determined by the Promoter.</p> <p>BP Fuelcard Applications will be subject to approval by the Promoter in accordance with the BP Fuelcard Terms and Conditions. BP Fuelcard Applications must satisfy the full information disclosure requirements as stated on the BP Fuelcard Application form, in order to be eligible.</p> <p>Processing of BP Fuelcard Applications and credit approval may take up to four (4) weeks from the date of submission in some cases, subject to full information disclosure. In the event that a Participating Business is not approved to become a BP Fuelcard business customer by the Promoter, the Participating Business will be ineligible to participate in the Offer.</p>

Discounts	<p>Once a Participating Business has been approved by the Promoter to become a BP Fuelcard business customer, their account has been fully set up by the Promoter, and they have received an internal bp credit approval, Participating Business will receive 12 cents per litre off the pump price of all unleaded and diesel fuel grades (excludes Autogas and AdBlue) for a period of three months commencing from the date the BP Fuelcard Application is approved, and expiring after three full calendar months have passed.</p> <p>Discounts will only be available where fuel transactions are made using the Participating Business' BP Fuelcard Account.</p> <p>Please note that:</p> <p>(a) Autogas and AdBlue are excluded from the Offer.</p> <p>(b) After the 3 month discount period has ended, a participating Business BP Fuelcard account will convert to:</p> <p>(i) 8 cents per litre off the pump price of premium fuel grades (95 Unleaded, BP Ultimate 98 Unleaded and BP Ultimate Diesel); and</p> <p>(ii) 8 cents per litre off the pump price of regular fuel (91 Unleaded and Diesel).</p> <p>Participation in this Offer is deemed acceptance of the BP Fuelcard Ongoing Base Offer Terms and Conditions.</p>

For the purpose of these Terms and Conditions, "participants" is deemed to apply equally to the Participating Business and to the authorised representative of the Participating Business.

- 2 These Terms and Conditions incorporate and must be read together with the details outlined in the table above. Information on how to participate and the discounts form part of these Terms and Conditions. By participating, Participating Businesses accept these Terms and Conditions.
- 3 A Participating Business must comply with BP Fuelcard Terms and Conditions at all relevant times and must remain a BP Fuelcard business customer at all relevant times to receive the benefits of the Offer. To the extent of any inconsistency between these Terms and Conditions, the BP Fuelcard Terms and Conditions and any other information provided by the Promoter, the Promoter will determine the prevailing term/s.
- 4 If a participant is deemed by the Promoter to breach these Terms and Conditions or the BP Fuelcard Terms and Conditions, their participation in this Offer and BP Fuelcard may be deemed invalid. The Promoter may, at any time, require documentation from participants to establish to the Promoter's satisfaction the validity of their participation (including documentation establishing identity and place of employment). Failure by the Promoter to enforce any of its rights at any stage does not waive those rights.
- 5 Participants must not:
 - (a) tamper with the participation process;
 - (b) engage in any conduct that may jeopardise the fair and proper conduct of the Offer;
 - (c) act in a disruptive, annoying, threatening, abusive or harassing manner;
 - (d) do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this Offer;
 - (e) breach any law; or
 - (f) behave in a way that is otherwise inappropriate.
- 6 The Promoter is not liable for claims or correspondence that are misplaced, misdirected, delayed, lost, incomplete, illegible or incorrectly submitted.
- 7 Offer is not valid in conjunction with any other offer, unless stated otherwise. Discounts are not exchangeable, transferable or redeemable for cash. The discounts must be taken as offered and cannot be varied unless authorised by the Promoter. Where relevant, the discounts include GST in each instance and the values stated are in New Zealand dollars.
- 8 The Promoter's decision in connection with all aspects of this Offer is final.
- 9 If this Offer cannot run as planned for any reason beyond the Promoter's control, for example due to software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, the Promoter may end, change, suspend or cancel the Offer.
- 10 The Promoter and the agencies and companies associated with this Offer are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this Offer, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed

by law).

If for GST purposes this competition results in any supply being made for non-monetary consideration, participants must follow the New Zealand Inland Revenue stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values .
