

WBC Be in to win a trip 2022 NZ BP PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these terms and conditions.
2. The promotor is BP Oil New Zealand Limited (Company Number 5068) of G 73 Watercare House 73 Remuera Rd Remuera Auckland, 1050 New Zealand ("**Promoter**").
3. The promotion is only open to New Zealand residents aged 18 years and over. Employees of the Promoter, and their immediate families, as well as the owners, managers, and staff of each bp store, and their immediate families, are ineligible to enter.

4. 12.01am on Wednesday 19th October and close at 11:59pm Tuesday 15th November 2022 during the promotional period in participating bp stores (Refer to Appendix 1).
5. The promotion is not run in association with any other retailers.
6. To enter the promotion, simply, during the relevant Promotional Period, purchase:
 - a) any Wild Bean Café branded triangle sandwich in a single transaction ("**Participating Products**") from any participating bp store; and
 - b) swipe your registered AA Smartfuel card or registered AA Membership card or registered Wild Bean loyalty card at the time of purchase
7. Limit of one (1) entry per transaction, regardless of the number of Participating Products purchased.
8. Any card used but not registered at the time of purchase at BP will not be eligible to enter into the prize draws
9. No retrospective entries can be made if a customer either fails to use their card at the point of purchase, or the customers AA Smartfuel, AA Membership or Wild Bean loyalty card is not registered.
10. Excludes Wild Bean Café hot sandwich range or pack baguettes. Only chilled packed triangle sandwiches are included.
