

WBC Be in to win a trip 2023 NZ BP PROMOTION

TERMS AND CONDITIONS

1. These Terms and Conditions provide information on how to enter and the prize involved in this promotion. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is BP Oil New Zealand Limited (Company Number 5068) of G 73 Watercare House 73 Remuera Rd Remuera Auckland, 1050 New Zealand ("**Promoter**").
3. The promotion is only open to New Zealand residents aged 18 years and over with a registered AA Smartfuel card, registered AA Membership card or registered Wild Bean loyalty card. Directors, owners, officers, management, employees and other staff of:
 - (a) the Promoter; and
 - (b) the agencies, companies and participating premises/stores associated with this Promotion,and their immediate families are ineligible to enter.
4. Entries into the promotion open 12.01am on Wednesday 23rd August 2023 and close at 11:59pm Tuesday 19th September 2023 ("**Promotional Period**") in participating bp stores listed in Appendix 1 ("**Participating Stores**") during the instore Promotional Period.
5. Participating Stores are operated by bp or by its franchisees. The promotion is not run in association with any other retailers.
6. To enter the promotion simply, during the Promotional Period, purchase:
 - a) any two Wild Bean Café branded sandwich packs in a single transaction ("**Participating Products**") from any Participating Stores; and
 - b) swipe your registered AA Smartfuel card, registered AA Membership card or registered Wild Bean loyalty card at the time of purchase (a "**Participating Card**").
7. Limit of one (1) entry per transaction.
8. Any Participating Card used but not registered at the time of purchase at BP will not be eligible to enter the prize draw.
9. No retrospective entries can be made if a customer either fails to use their Participating Card at the point of purchase, or the customer's AA Smartfuel, AA Membership or Wild Bean loyalty card is not registered.
10. This promotion excludes the Wild Bean Café hot sandwich range and pack baguettes. Only Wild Bean Café branded triangle sandwiches are included.

11. Multiple entries are permitted, provided that each entry is through a separate purchase of the Participating Products and in accordance with the entry requirements in these Terms and Conditions.
12. There is one prize available to be won. The prize on offer is a trip for two adults to a tropical destination (or whichever other destination the winner selects) in the form of a Flight Centre voucher equal to NZ\$10,000 (“Prize”). The Prize is subject to any additional terms and conditions reasonably imposed by Flight Centre or the Promoter, including the following:
 - (a) validity period/s;
 - (b) booking and availability of flights, accommodation and events;
 - (c) travel dates and specified travel exclusion periods;
 - (d) any additional fees (payable by the winner) relating to changes made by the winner/their companion to a travel prize after it has been booked;
 - (e) the requirement to obtain all necessary documents to travel to any overseas location specified, including a current and valid passport and any visas required; and
 - (f) a requirement to present a credit card when checking in to accommodation.
13. The Prize is not transferable, changeable, or redeemable for cash. The winner/their companion is responsible for all unspecified costs related to the Prize, including meals, insurance (including excesses), in-room charges and taxes. If you win the Prize, you are responsible for your companion and the Promoter may disqualify all entries from, and prohibit further participation in this promotion by, you or your companion if they breach these conditions, whether or not legally bound by them.

15. In the event that the Prize or any part of the Prize becomes unavailable for any reason beyond the Promoter's control, the Promoter may in its sole discretion decide to provide an alternative prize of equal or greater value.
16. The Prize winner will be determined by way of random draw from all valid entries received by the Promoter during the Promotional Period on **22nd September 2023**. The Prize draw will be conducted by Radium Ltd which has its offices at Level 3, Home Ideas Centre, 10 Hutt Road, Petone, Lower Hutt 501 (“**Draw Conductor**”). The Prize winner will be the first eligible entry randomly drawn by the Draw Conductor. The Draw Conductor may draw additional reserve entries (“**Reserve Entries**”) in case an invalid entry or entrant is drawn.:
17. The Prize winner will be contacted by phone or email using the contact details associated with either (as applicable) their registered:
 - a) AA Smartfuel card;
 - b) AA Membership card; or
 - c) Wild Bean Café loyalty card.
18. In the event that (a) an ineligible entry is drawn (for example, if the entrant does not meet the eligibility criteria described in Clause 3) or (b) the Promoter is unable to contact a winner and/or

obtain confirmation from the winner that the winner wishes to accept the prize (and of the email address to which the winner wishes the prize to be sent) within **7 business days** of the Prize draw, having made reasonable attempts to do so, the Promoter may deem that winner's entry invalid and award the Prize to a Reserve Entry or select a new winner on **4th October 2023** on the same terms as the original Prize draw. In that case, no compensation will be payable to the original winner.

19. The winner will be deemed to be the registered owner of the AA Membership card, AA Smartfuel card, or Wild Bean Café loyalty card associated with the winning entry. The Promoter, Draw Conductor and any other agencies or companies associated with this promotion are not responsible in any way for disputes arising as a result of entries being submitted by persons other than the registered owner of either the AA Membership card, AA Smartfuel card, or Wild Bean Café loyalty card used to complete the winning entry (as applicable).
20. The Prize will be delivered to the email address nominated by the winner within 31 days of the winner providing the Promoter, Draw Conductor and/or associated agencies or companies with a valid New Zealand email address for that purpose.
21. Acceptance of a Prize is deemed consent for the Promoter to use the winner's details (regional geographic location and first name, for example 'John, Auckland') for promotional and media purposes without compensation, and any copyright in such promotional and media materials will vest in the Promoter.
22. The Promoter's decision is final on all matters and no correspondence will be entered into.
23. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
24. The Promoter reserves the right to verify the validity of the winner's entry and disqualify any entry or refuse to award the Prize where false or misleading details have been given by an entrant or an entrant has behaved in a fraudulent, dishonest or disruptive manner, or otherwise than in accordance with these Terms and Conditions or the spirit of the promotion.
25. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its reasonable discretion, to determine the identity of the entrant.
26. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its reasonable discretion, to the fullest extent permitted by law and subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
27. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.
28. To the extent permitted by law, the Promoter and its agents take no responsibility for any failure of any entry to be entered into the promotion due to, without limitation, technical malfunction or human error. To the extent outside the Promoter's reasonable control, the Promoter and its agents are not responsible for late, lost, misdirected or incorrectly submitted entries. Incomplete or indecipherable entries will be deemed invalid.

29. Entries are deemed received at the time they are received by the Promoter, and not at the time of transmission by the entrant.
30. The Promoter is not responsible for any tax implications arising from you receiving the Prize.
31. The winner and their companion must, if required by the Promoter, sign disclaimer and release forms provided by the Promoter in favour of the Promoter and other parties before taking the prize. If the winner or their companion do not sign, the winner's entry will be deemed invalid, and they will lose any entitlement to a prize.
32. 34. The Promoter collects personal information about you in order to conduct and manage the promotion. If the personal information requested is not provided, you may not be able to participate. The Promoter may also use your personal information to help improve its goods and services. The Promoter may share your personal information with the Promoter's licensed dealers, related companies, agents, contractors or promotional partners for the purpose of conducting this promotion. Your personal information may be disclosed to overseas locations such as Australia, the USA, the UK, Malaysia, the Philippines and India for the purpose of conducting this promotion.  - (b) how you can complain about a breach of privacy and how the Promoter will deal with such a complaint.
